2. Nominee must be a member of NDCA and be serving in a counseling capacity during the current year.
3. Must submit the nomination form outlining the criteria for the award and two letters of reference.
4. Nominee cannot be a current member of the NDCA Executive Board.

## OUTSTANDING SCHOOL COUNSELOR AWARD

**Background and Purpose:** The purpose of this award is to honor a counselor for outstanding contributions to the schools they serve. This award may be bestowed upon (a) elementary counselor, (b) secondary counselor, or (c) K-12 counselor. More than one award may be given each year.

### Criteria:

1. Nominee must be a current member of NDCA and NDSCA.
2. Nominee must be a counselor who currently spends half their school time engaged in counseling activities at any grade level (pre K – 12) in a public or private school in North Dakota.
3. Nominees must have a minimum of three (3) years of school counseling experience.
4. Nominee must hold a current North Dakota Professional Guidance Credential.
5. Nominee must have extensive service and leadership conducting counseling activities in his/her school, community involvement and professional involvement at the NDSCA level.

### Procedure:

1. Any individual of a school or community may nominate a counselor
2. Nominee must meet all the above criteria.
3. Must submit the nomination form outlining the criteria for the award.
4. Must submit a minimum of two (2) letters of recommendation and supports (colleagues, parents, students, and community members).

## **OUTSTANDING MENTAL HEALTH COUNSELOR**

**Background and Purpose:** The Outstanding Mental Health Counselor Award is to be presented annually in conjunction with the North Dakota Counseling Association (NDCA) Midwinter Conference. The Award is an acknowledgment of contributions to and promotion of the mental health counseling profession.

**The following criteria are to be used in identifying the recipient:**

- A. Must be a current member of NDCA and NDMHCA with dues paid
- B. Must be a practicing Mental Health Counselor or Educator or retired from these vocations
- C. Has made outstanding contributions to the counseling field

**Procedures for Nomination:**

- A. The nomination must be made by a member of NDMHCA
- B. The nomination materials include the nomination form and two letters of recommendation. One of the letters should be from the nominee's supervisor, co-worker or former co-worker. Other materials may be included to support the nomination, such as news articles and civic awards. The materials are to be submitted to the NDMHCA Awards Chair by 1-01-2010  
The selection of the recipient will be made by the Executive Council of NDMHCA.
- C. Each year the nomination materials are to be made available to NDMHCA members in October.

The recognition will be in the form of a plaque.
